CHANGE OF DIRECTORS

The board of directors (the "Board") of San Miguel Brewery Hong Kong Limited (the "Company") announces that Mr. Francis H. Jardeleza, Mr. Estelito P. Mendoza and Mr. Gabriel L. Villareal have resigned as non-executive directors of the Company for personal reason, with effect from 24th February 2006. They have confirmed to the Company that there is no disagreement with the Board and there is no matter relating to their resignation that needs to be brought to the attention of the shareholders of the Company.

The Board is pleased to announce that Ms. Minerva Lourdes Bibonia, Ms. Ma. Belen C. Buensuceso and Mr. Roberto N. Huang have been appointed as non-executive directors of the Company with effect from 24th February 2006.

Ms. Minerva Lourdes Bibonia, aged 47, is currently the Senior Vice President, Corporate Marketing of San Miguel Corporation. She is also a Director of San Miguel Brewing International Limited, controlling shareholders of the Company. Ms. Bibonia has 25 years of combined Philippines and international marketing and sales experience for leading consumer and pharmaceutical brands. Prior to joining San Miguel Corporation in 2000, she was the Marketing Director of Abbott Laboratories Phils, Inc. and Pfizer, Inc., Product Manager of Bristol-Myers Squibb Company and Vice President, Marketing of Jollibee Foods Corporation. Ms. Bibonia graduated from University of Nueva Caceres with a Bachelor degree of Science in Commerce. She is a Certified Public Accountant of the Philippines.

Ms. Ma. Belen C. Buensuceso, aged 52, is currently the Senior Vice President, Corporate Planning & Development of San Miguel Corporation. She is also a Director of various subsidiaries of San Miguel Corporation. Ms. Buensuceso has more than 30 years of experience in strategic planning and financial analysis. Prior to joining San Miguel Corporation in 1978, she served as Professorial Lecturer in the University of the Philippines. Ms. Buensuceso graduated from St. Teresa's College with a Bachelor degree in Accounting and later obtained a Master degree in Business & Administration from University of the Philippines. She is a Certified Public Accountant of the Philippines.

Mr. Roberto N. Huang, aged 57, is currently the Senior Vice President of San Miguel Corporation and President of Coca-Cola Bottlers Philippines, Inc. He is also a Director of various subsidiaries of San Miguel Corporation. Mr. Huang has more than 25 years of experience in corporate sales and business management. Prior to joining San Miguel Corporation in 1999, he was the President of TRICIRCLE International, Inc., Vice President, Sales, Marketing and Purchasing of PICOP Resources, Inc. and General Manager of Nesium Wheels Mfg., Inc., Mercedes Commercial Printing, Inc., Philippines Technologies, Inc. and Monza Wheels Manufacturing, Inc. and the Dean of College of Engineering, Technological University of the Philippines. Mr. Huang graduated from Mapua Institute of Technology with a Bachelor degree in Mechanical Engineering and later obtained a Masters degree in Business Administration from De La Salle University of the Philippines.

Ms. Bibonia, Ms. Buensuceso and Mr. Huang did not hold any directorship with other listed companies in Hong Kong in the last three years. They have no relationship with any other directors, senior management, substantial or controlling shareholders of the Company. There is no designated length of service for Ms. Bibonia, Ms. Buensuceso and Mr. Huang with the Company. They will be subject to retirement by rotation and re-election at annual general meetings in accordance with the Articles of Association of the Company. There is no service contract between either Ms. Bibonia, Ms. Buensuceso or Mr. Huang and the Company and they are entitled to receive a director's fee to be determined by the Board from time to time.
